




This chart shows the total general purpose revenue Trivium Charter School Adventure expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Trivium Charter School Adventure is \$3,328,794, of which \$2934572 is Local Control Funding Formula (LCFF), \$313854 is other state funds, \$ is local funds, and \$80368 is federal funds. Of the \$2934572 in LCFF Funds, \$97740 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



# Increased or Improved Services for High Needs Students in the LCAP for the 2023-24 School Year

In 2023-24, Trivium Charter School Adventure is projecting it will receive \$97740 based on the enrollment of foster youth, English learner, and low-income students. # Update on Increased or Improved Services for High Needs Students in 2022-23



This chart compares what Trivium Charter School Adventure budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Trivium Charter School Adventure estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2022-23, Trivium Charter School Adventure's LCAP budgeted \$124,681 for planned actions to increase or improve services for high needs students. Trivium Charter School Adventure actually spent \$125,118 for actions to increase or improve services for high needs students in 2022-23.

The difference between the budgeted and actual expenditures of \$437 had the following impact on Trivium Charter School Adventure's ability to increase or improve services for high needs students:

The amount budgeted for the high needs students in the LCAP (124,681) is exceeded by the actual expenditures (\$125,118). Since every student receives a personalized learning plan and tailored curriculum and assignments, every student, including high need students, have an individualized plan that meets their needs and greatly improves their chance for success.

Trivium Charter School Adventure (TCSA) is one of three charter schools under the Trivium Charter School Network. TCSA serves students in a (t)K-12 and is designed as a hybrid learning model. Our students may attend classes on-campus for two full school days and completing their personalized learning plan assignments on the other days. Trivium offers a vast array of core subjects and electives, individualized pacing plans, and self designed elective options. Course options include computer-based courses, live (synchronous) classes, in-person classes, and traditional workbook/textbook options. Trivium embraces academic rigor and provides individual academic coaching and intervention plans to help students succeed. In addition, Trivium offers student, events and activities to provide students a well-rounded school experience where students learn to self-regulate with individual pacing and successfully interact with other students and staff members during class activities and events

#### **Reflections: Successes**

Trivium continues to be very strong in English/Language Arts and student engagement. Students are known by name at Trivium because our model focuses on Personalized Learning and requires students and/or families to be engaged in the academic success process. Our model encourages student engagement which results in a low absentee rate and a high graduation rate.

We will be researching and begin implementation of a structured student awards system. We will further develop our student support plan process to intervene and provide additional support as needed by dedicating additional resources, including personnel, as needed and as appropriate to support student progress and engagement.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). The LCAP development process serves three distinct, but related functions:

# Introduction

The State Board of Education (SBE) approved standards for the local indicators that support a local educational agency (LEA) in measuring and reporting progress within the appropriate priority area. The approved performance standards require an LEA to:

# **Performance Standards**

The performance standards for the local performance indicators are:

Appropriately Assigned Teachers, Access to Curriculum-Aligned Instructional Materials, and Safe, Clean and Functional School Facilities (LCFF Priority 1)

The LEA annually measures its progress in meeting the Williams settlement requirements at 100% at all of its school sites, as applicable, and promptly addresses any complaints or other deficiencies identified throughout the academic year, as applicable; the LEA then reports the results to its local governing board at a regularly scheduled meeting and to reports to educational partners and the public through the Dashboard.

### Implementation of State Academic Standards (LCFF Priority 2)

The LEA annually measures its progress implementing state academic standards; the LEA then reports the results to its local governing board at a regularly scheduled meeting and reports to educational partners and the public through the Dashboard.

### Parent and Family Engagement (LCFF Priority 3)

Our families rate our culture and responsiveness as very high and effective. We are continuing to work on increasing our math test scores and are adding an additional class option to meet the needs of students.
