The Blochman Union School District engaged in meaningful consultation with school leaders, teachers, school staff, the Special Education administrator, district administrators, and the local bargaining unit on August 16, 2021, during a staff meeting.

The Blochman Union School District attempted to engage in meaningful consultation with students, families, and non-English speaking families on August 10, 2021 by way of a properly noticed public meeting of the Blochman Union School District Board of Trustees. In spite of numerous attempts to invite these groups to attend the meeting, the district was unable connect with representative members from these groups at this meeting. However, the district Superintendent has had numerous individual meetings and telephone calls with members of the student and families groups. The Special Education Director has had numerous individual meetings and telephone calls with non-English speaking families. Information gathered from these individual meetings was used in the development of the plan.

The Blochman Union School District evaluated its stakeholder engagement opportunities and determined that Tribes, Civil Rights organizations, and advocates representing the interest of underserved students are neither present nor served by the district.

The development of the plan was influenced by input from our stakeholders. Input from teachers, school staff, the Special Education Director, students, and families (including non-English speaking families) was considered when determining to implement the summer reading program and the after-school program. ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
