## IPM statement

It is the goal of Blochman Union School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

1. Provide a safe learning environment.
2. Minimize chemical pest control.
3. Prevent pests from entering District facilities.

## IPM team

In addition to the IPM Coordinator, other individuals who are involved in purchasing, making IPM decisions, applying pesticides, and complying with the Healthy Schools Act requirements, include:

## Pest management contracting

## Pest identification, monitoring and inspection

Pest Identification is done by: Santa Barbara County Agriculture Commissioner's Office

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Maintenance staff, Food Service Manager and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

1. During daily cleaning, maintenance staff check for evidence of pests; droppings, chewed paper and/or cardboard, carcasses.
2. Possible pest activity is reported to the IPM Coordinator for correction.

## Chemical pest management practices

## Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

(Education Code Section 17610.5)
